Dear Sir/Madam,

As you are aware, UGC-WRO has conveyed the XII Plan allocation in the form of Block Grant (PBG) to the Colleges and has also released approximately 40% of grant as the first instalment. All the Colleges were requested to submit the details of item-wise XII Plan allocation, as per the XII Plan guidelines for Development Grant to Colleges, by 30th June, 2014, duly signed by the members of Planning Board. We have received the information from most of the Colleges but some of the Colleges are yet to furnish the required information.

The Colleges are now eligible to receive next instalment of grant for 2014-15, however, next instalment of grant will be released on receipt of the following documents :-

1. Utilization Certificate and statement of expenditure for the first instalment of grant released during XII Plan (PBG).
2. Settlement of XI Plan accounts (for General Development Assistance & Merged Scheme).
3. Details of item-wise XII Plan Allocation (Annexure-I & II of the XII Plan Guidelines for General Development Assistance) prepared by Planning Board of the Colleges, duly signed by all members of Planning Board.

So far as construction of building is concerned, you are requested to send the documents as per XII Plan guidelines for General Development Assistance for construction of building, along with certified copies of title deeds of the land on which the college proposes to construct the building OR Certificate regarding area and complete address on which the construction is proposed to be undertaken.

I would also like to inform you that the grant of Rs.3.00 lakh sanctioned for the Establishment of IQAC can be utilized up to the end of XII Plan.
