#### Note:

1. All Candidates have to remain present 30 minutes before commencement of counseling at venue to till announcement of conclusion of counseling. If any candidate leaves the hall during counseling, he/she loose the claim of his/her seat.
2. If candidates could not come in person then authorized person can come with proper authority letter, he/she will be considered for counseling.
3. The parents and relatives of the candidates are barred from entry in the hall.
4. Candidate must bring all the original documents ( Birth Certificate / School Leaving Certificate / Indian Passport for Birth Date & Birth place /Citizenship., Mark Sheet of MD/MS course or Equivalent course Examination, Passing Certificate of MD/MS course or Equivalent course Examination, Attempt Certificate of MD/MS course or Equivalent course Examination, Certificate regarding MCI recognition of MD/MS course or Equivalent course Examination from Competent Authority of Concerned Institute/College, Permanent Registration M.B.B.S / Additional registration of M.D/M.S/ or Equivalent course Examination, No Objection Certificate from the Institute/College for the candidate who is presently doing job anywhere, For In Service Candidates, study leave / resignation or NOC (As per Rule7.8))in the same sequence should kept in one big envelop. Merit no., Full Name, Full Permanent Address, Mobile Number with all other details should be Mentioned on envelops.
5. Verification of all the original documents will be done before counseling. The envelope containing all original documents will be kept by the respective Institute if the candidate gets the admission.
6. All M.ch. / D.M. courses are full-time and the candidate shall not indulge in any type of private practice or employment of any nature (Part-time, paid or stipendiary or unpaid) during the course. If the candidate is employed, he shall have to produce proof that he has left the service or taken leave for full period of the course before he is given admission order in first counselling. But in case of Reshuffling Counselling, If the candidate is employed, he shall have to produce proof that he has left the service or taken leave for full period of the course on or before Reshuffling Counselling. No concession will be given regarding joining period prescribed by PG Admission Committee, counted from the day of selection. If he fails to produce the above proof within period prescribed by PG Admission Committee,, his admission shall stand cancelled without any notice, fees and deposits will be forfeited and will not be eligible to apply in future
7. The Candidates who take admission in DM/M.Ch at B.J. Medical College, Ahmedabad shall have to execute the bond of Rs.50 Lakhs as per the GR of Government of Gujarat.

8. The Candidate should come with Rs.65000/- (Rupees sixty five Thousand only) in cash. (As a part of University fee Rs.30000/- (Approx.) and Deposit as Applicable)  
The Approx. tuition fee of B.J.Medical College – Nil; NHL Medical College – Rs. 4 lacs per year (Provisional).
