Admission Notice

Post Basic B.Sc.Nursing Course-2015

1. Applications in the prescribed form are invited for admission to the post basic B.Sc Nursing courses of Gujarat University. Application forms (along with relevant rules applicable) will be available on the website of Gujarat University www.gujaratuniversity.org.in as per programme shown in Para-1 (Old forms are invalid).
2. The candidates are instructed to download and print the Application form from the website. The filled application form with all relevant Documents should be submitted at Room No.33 Academic Section 1st Floor, Gujarat University office .Ahmedabad with Demand Draft of Rs.500/- as application form fee in the favour of "Chairman, P.G.Medical Admission Committee,Gujarat University" payable at Ahmedabad. The filled application form will be accepted as per programme shown in Para-1.
3. The application form before submission should be complete in all respects in every detail duly certified copies of required documents should be attached No alteration of addition will be permitted later on.
4. None of the accompaniments will returned. All original certificates, the copies of which are attached to the application form must be brought at the time of submission of application form for verification if required and at the time of Counseling. Last date of acceptance completely filled application form is as per the programme shown in para-1
5. Every candidate will be issued a receipt when he/she submits his /her application form this must be preserved for all future references and produce when asked for and at the time of counseling. (Receipt with recent Passport size photographs attested by Gazetted officer/Principal of College with stamp)
6. Only those applications along with form fee and required documents received up to last date will be considered. Any application received later than the last date, application with insufficient details or lack of required documents or required fees shall be rejected without any explanation even if it is received within date and time.
7. If any of the statements made in the application form or any information / document supplied by the candidate in connection with his / her application for admission is later on found to be false or incorrect or misleading or if it is found that the candidate has concealed any information / fact in connection with his / her application, his / her admission and registration shall be cancelled without any notice thereof, fees forfeited, have to pay the whole course fees and he / she may be expelled and prosecuted, and he / she will not be eligible to apply in future.
8. He/She must be a Indian Citizen He/She must be medically fit.
9. The Candidate must have completed the GNM Course from recognized institute/College.
10. A candidate who is engaged (at the time of submission of application) in Post Basic B.Sc Nursing studies in this University or any Other University or equivalent body is not eligible.
11. A candidate who in the past selected and admitted to any Post Basic B.Sc Nursing course of this or any other university or equivalent body and did not complete that course, at the time of submission of application, is not eligible. However, those candidates who have cancelled their admission with Gujarat University Admission Committee before reshuffling counseling (through head of institute/college) or surrendered his seat during reshuffling counseling is eligible.

12. A Candidate who had applied earlier to this University and who was disqualified because of reason mentioned in Rules 6.5, 7.8, 7.10, 7.12 is not eligible.
13. A candidate who is graduate of a University other than Gujarat University will have to submit provisional eligibility certificate (P.E.C.) from the Gujarat University within one month from the date of his / her admission, failing which the admission of candidate shall be cancelled without any notice thereof, fees forfeited and will not be eligible to apply in future. This Provisional eligibility certificate (PEC) should be submitted / checked by respective institute / college where candidate gets admission.
14. All the applications will be considered for category students but if any candidate wishes to claim admission under SC/ST/SEBC category seats for this respective category. He/she should furnish details in application form along with relevant documents mentioned thereof. The allocation of seats to this reserved category will be decided as per the roster register maintained separately by the affiliated Institutions/Colleges of Gujarat University.
15. The Post Basic B. Sc. Nursing course is full-time and the candidates shall not indulge in any type of private practice or employment of any nature (Part – time or Full – time, paid or stipendiary or unpaid) during the course. If the candidate is employed, he shall have to produce proof that he has left the service or taken leave for full period of the course before he is given admission order. No concession will be given regarding joining period prescribe by admission committee. If he fails to produce the above proof within prescribe time limit, his admission shall stand cancelled, fees and deposits will be forfeited and will not be eligible to apply in future. (If the candidate is serving as Tutor/Clinical Instructor etc., in the same specialty/department in which institution he is selected, he may continue the post.)
16. The selected and admitted candidate will have to join within stipulated time prescribe by admission committee. If he fails to do so as well as if he leaves before completion of the course, his / her admission and registration shall be cancelled without any notice thereof, fees forfeited, have to pay the whole course fees and he / she may be expelled and prosecuted, and he / she will not be eligible to apply in future.
17. If any Post graduate student is found absent for more than 72 hours (in case of before the last date for Completion of entire Admission process as per rule 3.1) and 15 days (in case of after the last date for Completion of entire Admission process as per rule 3.1) without leave/permission / information of competent authority, his / her admission and registration shall be cancelled without any notice thereof, fees forfeited, have to pay the whole course fees, he / she will not be eligible to apply in future.

2. Attempts Certificates of 3 rd , 2 nd , 1 st , year of GNM
3. Caste Certificate (Please attach 2 Xerox copies) for SC/ST/SEBC
4. Non Creamy layer Certificate for current financial year i.e issued on or after 1 st April 2015(Please attach 2 Xerox copies) for SEBC category.
5. School leaving Certificate (Please attach 2 Xerox copies)
6. Certificate regarding Medical Fitness.
7. 12 th Standard Marksheet
8. 10 th Standard Marksheet
9. Registration Certificate of GNM course issued by respective State Nursing Council /State
10. Two Self –addressed envelope with postage stamp
