Note:

1. All Candidates have to remain present 30 minutes before commencement of counseling at venue and till announcement of conclusion of counseling, If any candidate leaves the hall, he/she loose the claim of any seat.
2. If candidates could not come in person then authorized person can come with proper authority letter will be considered for counseling.
3. The parents and relatives of the candidates are barred for entry in the hall.
4. The candidates must have completed Internship before the date of counseling. Candidate should have to **produce full internship completion certificate at the time of first counseling**, failing which, candidate will not be eligible for admission.
5. Candidate must bring all the original documents with following sequence[Mark sheet of all year, Attempt Certificate, Internship Completion Certificate, Caste certificate, , Non Creamy layer Certificate of financial year pertaining to the period of application from the competent authority as prescribed by the Govt. of Gujarat for SEBC, School leaving certificate, Certificate of completion of PG Course (If Applicable), For In-service Candidates- study leave/resignation/NOC as per rule 7.8] & same should kept in one big envelop. Merit no. Full Name, Full Permanent Address, Mobile number with all other details should be Mention on envelop.
6. Verification of all the original documents and undertaking (Attached herewith) on Stamp paper of Rs.20/- as per rule 7.13 of Post graduate admission will be done before counseling. Any candidate failed to produce any original document/undertaking will not be included for admission process. The envelope containing all original documents will be kept by the respective Institute if candidate will get the admission in any branch.
7. Admitted candidate should pay University fee [Rs. 18832/- (Male/Female Candidates), Rs.15332/- (Female Candidates for Govt. Institutes only)] and tuition fee/ Deposit as applicable.
8. After completion of selection process, the candidate will be call again for allotment of P.G teacher as per merit. After allotment of P.G. Teacher, the admission committee will give the admission order to the candidate. After getting admission order the candidate must join the institute in time limit prescribed in admission order.
9. Seat Matrix will be available on the Website of Gujarat University www.gujaratuniversity.ac.in in due course.

10. All candidates have to submit the undertaking (Attached herewith) on Stamp paper of Rs.20/- as per rule 7.13 of Post graduate admission at the time of Counselling failing which candidate will not be considered for counselling.
