Programmes:

- 1. 5 Years Integrated Programme (Degree/Diploma) in Computer Science (UG + PG) Level
- 1. 5 Years Integrated Programme (Degree/Diploma) in Commerce & Management (UG + PG) Level
- 3. 5 Years Integrated Programme (Degree/Diploma) in Business Studies (UG + PG) Level
- 4. 5 Years PG Programmes in Defense & Security services, HRM, Fashion Designing, Hotel Management, Tourism Management, Disaster Management, Agriculture & Dairy Management, Banking Management & Infrastructure Management

The trust proposes the following fee structure for the above mentioned programmes:

FEE STRUCTURE :

- 1. PROPOSED FEE STRUCTURE FOR ALL PG. PROGRAMS:
 - (a) All PG Programs Rs. 25,000 per semester for the regular seats.
- PROPOSED FEE STRUCTURE FOR ALL FIVE YEAR INTEGRATED PROGRAMS:
 - a. Fee for the first three years in Commerce and Management will be Rs 10,000 per semester for the regular seats.
 - Fee for the first three years in Computer Science and Business Management will be Rs. 15,000 per semester for regular seats.
 - c. Fee for the last two years will be Rs. 25,000 per semester for the regular seats
- There shall be a 10% increase in the fees every year and the fees structure will be revised every three years.

MEMORANDUM OF UNDERSTANDING

GYANJYOT EDUCATION TRUST

Nr.Cambay Hotel, Thaltej, Ahmedabad. Gujarat.

This Memorandum of Understanding is made on this day 10th of January in the year 2013 between Gujarat University, Navrangpura, Ahmedabad, represented by its Registrar as the First Party (herein after referred to as "GUJARAT UNIVERSITY" or the "First Party") and GYANJYOT EDUCATION TRUST, having its office at Thaltej, Ahmedabad. Sri. Naresh M. Patel as the Second Party (herein after referred to as "GYANJYOT EDUCATION TRUST" or the "Second Party")

The two parties to this Memorandum of Understanding (MOU) accept the following terms and conditions with a common intention of being legally bound on them.

WHEREAS Gujarat University is an affiliating University at the under-graduate level, while it is a teaching university at the post-graduate level, and accordingly it has devised a plan of co-ordinated instruction under the direct control and supervision of the University so as to ensure efficient and diversified instruction. Gujarat University is recognized as a Premier University in the country today. It provides education to about Three Lakh students.

WHEREAS

The GYANJYOT EDUCATION TRUST was established on 21st Aug. 1997. Shri Naresh M. Patel is the managing trustee of this trust. It governs a cluster of institutions with ensuring successful delivery of the courses or programs offered in it. The trust also provides a wide range of facilities to ensure the smooth functioning of the institutions. This includes ac classrooms, well equipped labs , well equipped library and reading platforms, well trained, qualified and experienced staff, wifi facility, hygienic canteen and many more.

1. ACADEMIC DELIVERY:

Academic delivery of the following programmes:

- 1. 5 Years Integrated Programme (Digree/Diploma) in Computer Science (UG + PG) Level
- 2. 5 Years Integrated Programme (Digree/Diploma) in Commerce & Management (UG + PG) Level
- 3. 5 Years Integrated Programme (Digree/Diploma) in Business Studies (UG + PG) Level
- 4. 2 Years PG Programmes in Defense & Security services, HRM, Fashion Designing, Hotel Management, Tourism Management, Disaster Management, Agriculture & Dairy Management, Banking Management & Infrastructure Management.
- Allied / related courses may be added with mutual consent.

to its contents. The prospectus shall be sold and sale proceeds so realized shall be retained by the Second Party.

- h) Project reports submitted by students as partial fulfillment of Bachelor Degree and Master Degree shall be the property of the First Party.
- Organizing of study lectures for theory and practical classes and payment of those lectures is the responsibility of GYANJYOT EDUCATION TRUST.
- j) Shall be responsible for completion of both theory and practical training sessions of courses within the prescribed period for which admissions have been made through GUJARAT UNIVERSITY/ GYANJYOT EDUCATION TRUST.
- k) Shall provide all possible assistance to GUJARAT UNIVERSITY for the conduct of examination.
- Shall prepare publicity materials of the programs to be launched and display them in different media
 after ensuring that they are in conformity with the course. Such publicity must prominently display
 the name of GUJARAT UNIVERSITY and its logo, such advertisement materials must be approved
 by GUJARAT UNIVERSITY, prior to its publication.
- m) Admission notification and advertisement shall also be prepared and published from time to time, after ensuring that they are in conformity with course. The cost of such Advertisement will be shared equally by GUJARAT UNIVERSITY and GYANJYOT EDUCATION TRUST
- n) Shall ensure adherence to quality standards prescribed by GUJARAT UNIVERSITY from time to
- GYANJYOT EDUCATION TRUST shall keep its web site updated regarding the courses.
- p) Shall extend centres to run the courses offered under this MoU only to the colleges/institutions affiliated to Gujarat University.
- q) Library
- r) Cup boards
- s) Computer systems with other peripherals like printers, Scanners & multimedia equipments etc, as per course requirements.
- t) Fax, e-mail and Internet facilities.

4. RESPONSIBILITIES OF GUJARAT UNIVERSITY:

 a) Shall allocate suitable & sufficient land within Gujarat University campus to second party to construct new building for above mention innovative courses.

Ownership of the Land & Building will remain with Gujarat University.

- b) Shall accept admission of enrolled students, along with prescribed tuition fees and provide the receipt for the same.
- c) Shall after receipt of the processed applications and fees, finalize the admissions as per rules and inform the registration/enrollment numbers of the students.
- d) Shall provide an appropriate share from the tuition fees received from the enrolled students as decided in clause no.7 (2) and 7. (3) to GYANJYOT EDUCATION TRUST.

7. FEE STRUCTURE:

- The tuition fee / lab fee, registration fee and examination fee per student per year / semester will be prescribed jointly by GUJARAT UNIVERSITY and GYANJYOT EDUCATION TRUST, from time to time.
- 2. Prescribed Tuition Fees will be shared in following manner:
 - GYANJYOT EDUCATION TRUST share will be allotted 60%.
 - GUJARAT UNIVERSITY share will be allotted 40% from the tuition fees.
- 3. Prescribed Tuition Fees in the case of affiliated centers will be shared in following manner:
 - Affiliated College/Centre share will be allotted 60%.
 - GYANJYOT EDUCATION TRUST share will be allotted 20% and the GUJARAT UNIVERSITY will also share 20%.

8. No. of Seats per Intake:---

- Years Integrated Programme (Digree/Diploma) in Computer Science (UG + PG) Level 150
 Students
- Years Integrated Programme (Digree/Diploma) in Commerce & Management (UG + PG) Level-150 Students per Division (4 Divisions).
- Years Integrated Programme (Digree/Diploma) in Business Studies (UG + PG) Level- 150
 Students
- Years PG Programmes in Defense & Security services, HRM, Fashion Designing, Hotel Management, Tourism Management, Disaster Management, Agriculture & Dairy Management, Banking Management & Infrastructure Management. – 60 Students each.
- If the number of enrollment for any course is higher than the allotted seats, the extra seats will be considered as special seats and the Special Fee will be applicable.

9. EVALUATION:

Examinations shall be of semester exams. All the final exams shall be of credit based/GUJARAT UNIVERSITY Norms as and when applicable. The examination fees will be fixed by the Registrar (Evaluation) from time to time through the University notification.

10. LIABILITIES:

- a) GUJARAT UNIVERSITY shall not be liable for any payments of claims by employees of the Second Party.
- b) GUJARAT UNIVERSITY shall not be liable for discharging any financial commitments made by the Second Party.

11. JURISDICTION:

In the event of any disputes between the parties only the courts in Ahmedabad city shall have exclusive jurisdiction. But no court case shall be preferred by either party until Arbitration has been resorted to and proved unfruitful.
